

RODEO GROUNDS DAILY USAGE POLICY

THIS USE AGREEMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, by and between the Town of Meeteetse, a Municipality, hereinafter referred to as "Meeteetse", and \_\_\_\_\_, hereinafter referred to as "User":

WITNESSETH:

WHEREAS, Meeteetse is the owner of the "facilities" located at 5085 Highway 120, aka. the rodeo grounds,

1. Meeteetse does hereby grant to "User" the right to use said "facilities" for the period of \_\_\_\_\_ to \_\_\_\_\_.
2. User will pay the Town of Meeteetse the sum of **\$25.00** a day up to 25 head. Any additional livestock charge will be a \$1.00 per head per day.
3. \$1000 damage/cleaning deposit will be required if there is more than 25 head. This deposit will be returned to "User" after inspection by authorized Town of Meeteetse personnel have determined that the "facilities" are clean and no damage has occurred.
4. User will be solely responsible to return the "facilities" in as good or better condition than they were found to be in.
5. "User" has inspected the "facilities" and accepts the "facilities" are in good condition and acknowledges responsibility for all damages thereof whether covered by the damage/cleaning deposit or in excess thereof.
6. In the event the "facilities" are damaged while in "User's" possession to an extent which makes it non-repairable or irreplaceable, then "User" will pay the Town of Meeteetse the sum of all replacement costs; including labor.
7. Due to the nature of the floor of the arena there will be **NO VECHILES Allowed inside the arena**. Any work done to the floor of the arena will be performed or contracted by authorized Town of Meeteetse personnel.
8. Absolutely no fire of any kind including camp fires.
